INSURANCE

Travel insurance - Each passenger must be covered by Health Insurance while on a Casterbridge tour (insurance coverage is gratis for all free group leaders). Casterbridge offers a comprehensive Travel Insurance Policy, which includes full Health, Cancellation and Property coverage and costs: for trips of 1 to 10 days - \$69 for those age 30 or younger (\$99 for tours of 11 or more days) and \$109 for those age 31 or older (\$129 for tours of 11 or more days). A policy document and full details of the policy schedule and contents will be forwarded to you by our US liaison Office.

DEPOSIT AND FINAL PAYMENT

I understand that our booking can only be confirmed after Casterbridge Tours' receipt of our deposit. I am aware that the outstanding balance must be received by Casterbridge Tours in Virginia at least 90 days prior to our departure in order to maintain the free places allocated to our group.

Booking Information

How to Book

1. If you are interested in bringing a group on a Casterbridge Tour, you can immediately contact Casterbridge Tours on our Toll Free number **1-800-522-2398** (From anywhere in the USA and Canada).

We will immediately provide you with a written itinerary and Quick Quote for your proposed tour, together with any additional information that you require. Our quotation will be based on the most competitive scheduled air fare currently available from the departure city of your choice. We will always quote in US Dollars for American groups, Canadian Dollars for Canadian groups, Australian Dollars for Australian groups and Pounds Sterling for British groups.

2. Our Quick Quote will be accompanied by a copy of our Group Leader's Handbook which will contain many invaluable tips in regard to publicizing your proposed tour and recruiting a group. We will also forward you several posters to help publicize your tour, together with individual enrollment forms that will provide participants with full details of Casterbridge Tours.

3. To secure your booking you should send us a SINGLE CHECK representing US\$500/CAN\$750 for each participant as deposit and a completed Group Booking Form giving us full details of your group.

4. After receiving your deposit, we will send you a statement confirming your booking and notification of the date when your final payment is due. Our statement will be accompanied by our Travel Information Pack which many Group Leaders have found particularly useful in the planning of their trip.

5. As we have many commitments that have to be prepaid, your final payment must be received in England 90 days before your departure. After your final payment has been received we will send you your final receipt.

6. You will see from details of our Price Guarantee Plan below that no price increases will be made once your final payment has been acknowledged and airline tickets have been issued.

Our Price Guarantee

The size of the group at the time of the final payment due date shall determine the final tour price, final number of free places and any booking bonus. Final Payment must be made by Wire Transfer or Certified Check.

Once final payment has been acknowledged and the group's airline tickets have been issued, there will be no price increase whatsoever.

Furthermore, we can offer you a better guarantee at the time of receiving your deposit than most other Operators offer after you have made full payment. Providing your deposit is received three months prior to your tour commencement date, once your booking has been acknowledged, your costs are guaranteed against everything except a fall in the value of the US or Canadian dollar beyond the level that is clearly stated on your personal proposal or any airline or government imposed increases in taxes or fuel surcharges. For those groups who make a late booking within the three months prior to their tour dates, we reserve the right to charge up to an additional US\$12/CAN\$18 per person per night. This charge will only be levied for those nights when it is necessary to pay a premium to secure hotel space if our normal hotel accommodations are no longer available.

Most other Operators will add a surcharge if they do not recruit additional students to join your group. With Casterbridge Tours you will always travel as an independent group so this does not apply. Even with partial payment, Casterbridge Tours offers you a better guarantee than other Tour Operators.

Cancellations and Refunds

Most tour operators do not offer any refund to participants who cancel in the weeks immediately prior to their departure date. Casterbridge Tours appreciates that on certain occasions unforeseen circumstances may conspire to prevent a participant from travelling and our cancellation policy is as follows:

If a group member withdraws from the tour in the period from the date of booking until 90 days prior to departure, the cancellation fee is equal to the deposit paid. For cancellations between 90 and 76 days before departure, a refund of 50% of the full tour cost, less any insurance premiums, will be made. For cancellations between 75 and 61 days before departure, a refund of 40% of the full tour cost, less any insurance premiums, will be made. For cancellations between 60 and 15 days before departure, a refund of 25% of the full tour cost, less any insurance premiums, will be made. For cancellations from 14 days before departure, no refund will be made.

The amount withheld for a cancellation can be covered by our Travel Insurance subject to qualified injury, illness, circumstances, etc. In such instances, an insured group member should receive a full refund between Casterbridge Tours and your Insurers. Consequently, we strongly advise each group to take out our Travel Insurance Option.

Please note that we must be notified of all cancellations by telephone and a written confirmation received by our tour operations department from your group leader within the above timeframe to qualify for any refund. Verbal cancellations alone are not acceptable.

Musical Notes

In order that we can commence with arrangements for the concerts for your group, we need as much detailed information as possible relating to the choir, orchestra or band. In particular we require:

- Background information on the Choir, Orchestra or Band
- The repertoire - eg: Classical, Choral, Madrigals, Folk, Sacred, Songs from the Musicals, Jazz, Pop etc.
- Details of the Music Director and, if applicable, the pianist/organist
- Any programs or printed materials relating to previous concerts or tours
- A CD of your choir, and/if available photographs
- Stage requirements - also, whether you will require the use of piano/organ or any special equipment
- Confirmation as to whether the choir will be accompanied or unaccompanied
- Preferred venues: e.g. churches, cathedrals, schools, concert halls, selection of outdoor venues
- Preferred duration of concerts
- Required rehearsal time (if applicable)
- Any other relevant information

Please forward this information with the booking form and deposit, or at your earliest convenience. We will be unable to start making arrangements until we have received these details, as we have found that local contacts require this information prior to agreeing to host a visiting group or promoting a concert.

BOOKING CONDITIONS

Booking acceptance and payment terms

1. A booking will be considered binding on both sides upon receipt of a signed Group Booking Form or a deposit of US\$500/CAN\$750 for each paying group member.
2. In accepting your booking, Casterbridge Tours Ltd. (the Company) agrees to carry out our obligations to you the Group Leader as described in our brochure and other documents supplied to your group. The Group Leader is our client and responsible for the booking and acts on behalf of all party members in his/her dealings with us.
3. The balance of the payment must be received by the Head Office of the Company, in England, at least 90 days prior to the tour commencement date. Final payment must be made by Wire Transfer or Certified Check. Late payment will incur a penalty of US\$150/CAN\$225 per person plus interest at 4% above the UK base rate for the overdue period. Please note that qualification for any stipends, loyalty payments, discounts, repeat booking payments etc. is strictly conditional on adherence to our Booking Conditions. Late payment will invalidate such stipends or discounts.
4. Your group's quote and invoice will show the exchange rate guarantee applicable to your tour. If your balance is received and the exchange rate is higher than the stated rate, a currency surcharge will apply. If applicable, an invoice will be provided indicating the currency surcharge owed. Once the surcharge has been acknowledged, this will be deemed as your final payment for the land portion of the tour.
5. Your group's quote and invoice will also show the amount that has been included in the tour prices at the time of booking for airline taxes and fuel charges. Any additional government-imposed taxes or airline-imposed fuel surcharges that are levied subsequent to final payment, but before time of ticketing, will be invoiced to the group. Once this payment is acknowledged, there can be no price increase whatsoever.
6. There is a US\$150/CAN\$225 administration charge plus any additional fees and price differences for any and each subsequent change requested to an itinerary or tour content after the Booking has been accepted. Such changes will only be accepted in writing from the Group Leader subject to the approval of our Head Office.
7. If any member is added to the group (or substituted for another group member) in the period between 90 and 45 days prior to the departure, a Late Booking Fee of US\$150/CAN\$225 will apply. However, you should be aware that closer to departure, availability may be reduced or non-existent, and flight prices may well increase. For this reason, we cannot guarantee the existing price for late sign-ups, and will quote a revised price. No participants can be added or substituted in the final 45 days prior to departure.

Flights

8. Flight-inclusive costings are based on group net fares which require a group to travel together. However, we will be pleased to try and arrange alternative return dates from the same gateway cities for individuals for an administration fee of US\$75/CAN\$125, plus any supplement imposed by the airline. Such requests must be made in writing at the time of booking. The Company will provide a land-only quotation for any individual wishing to make their own alternative flight arrangements.
9. In rare instances when an airfare has not been contracted with the airline prior to the time of booking, or there are any airline or government imposed increases in taxes or fuel surcharges after time of booking, the group leader would be notified of the circumstances and any increase in the air portion prior to final payment would be added to the tour cost.

Cancellation terms

10. If a group member withdraws from the tour in the period from the date of booking until 90 days prior to departure, the cancellation fee is equal to the deposit paid. For cancellations between 90 and 76 days before departure, a refund of 50% of the full tour cost, less any insurance premiums, will be made. For cancellations between 75 and 61 days before departure, a refund of 40% of the full tour cost, less any insurance premiums, will be made. For cancellations between 60 and 15 days before departure, a refund of 25% of the full tour cost, less any insurance premiums, will be made. For cancellations from 14 days before departure, no refund will be made.
11. To cancel a group tour, the group leader must request a full cancellation in writing. No tour will be deemed cancelled until the Company has given the group leader written confirmation of cancellation. For cancellations between 90 and 76 days before departure, a refund of 50% of the full tour cost, less any insurance premiums, will be made. For cancellations between 75 and 61 days

before departure, a refund of 40% of the full tour cost, less any insurance premiums, will be made. For cancellations between 60 and 15 days before departure, a refund of 25% of the full tour cost, less any insurance premiums, will be made. For cancellations from 14 days before departure, no refund will be made.

12. If sufficient individual cancellations cause the total number remaining in the group to fall below the minimum number the Company requires to operate the tour, the Company reserves the right either to amend the itinerary and/or tour content, or to apply Group Cancellation terms as above.

13. To qualify for a cancellation refund, our Head Office must be notified in writing within the above time periods.

Free Places

14. Group Leaders travelling on a Free Place should note that this covers the standard package only and does not include any Single Room or other supplement for additional services.

15. The Company reserves the right not to allow the substitution of a person on a Free Place. The group will be responsible for any expenses incurred if such a substitution is allowed. The substitution of a previously paying group member to take a free place will not be allowed.

Accommodation

16. If your group has booked at least 90 days prior to travel and if for any reason we are unable to provide the agreed level of accommodation, we will reimburse all paying group members the sum of US\$6/CAN\$9 per night.

17. If your group has booked within 90 days of travel, we reserve the right to add a premium to the tour cost of US\$12/CAN\$18 per person per night for those nights when our normal accommodation is not available.

Insurance

18. It is the Group Leader's responsibility to ensure that all group members are properly informed of the consequences of not having adequate travel insurance cover for items such as cancellation, accidents, illness, theft and loss or damage to their property. Until we are advised that Casterbridge insurance is being specifically declined, we will invoice on the basis that it is required for all participants. In instances where Casterbridge insurance has been declined we would then also require details of alternative medical health cover.

Waivers

19. The Company will not be liable for any damage, loss, injury, delay or inconvenience caused by any company, organization, agent, person or persons providing facilities or services in connection with its tours, including without limitation, airlines, bus companies, ferry operators, railways, tour operators, hotels and schools.

20. The Company will not be liable for loss, damage or injury to persons or property, including without limitation, baggage, personal effects, money, passports, tickets or travel documents, nor for events beyond its control, including without limitation Acts of God, war, weather, strikes or government restrictions.

21. In providing ground services for your tour, the Company acts as an Agent for Eagle Coaches, Brents Coaches, COSEA, TRAPSA, Cityrama and Hoverspeed. However, we reserve the right to use other agents or any other non-agency carrier as appropriate.

22. Although we will make all efforts to ensure that this is not necessary, Casterbridge Tours reserve the right to make alterations to our itineraries and tours for reasons which we believe to be sufficient and proper.

23. No refunds are made for unused land services such as meals, accommodations, theater visits, transportation, etc., missed by group members through absence or any other reason once the tour has started.

Student Groups

24. Damage caused deliberately or by carelessness to Casterbridge Tours property, hotels we use and their property and/or property of staff and other visitors must be paid for by the person responsible for such damage.

25. The Group Leader is responsible for the behavior and discipline of the group and for any damage caused by a member of that group.

26. Casterbridge Tours reserves the right to remove a student from a tour if their behavior is prejudicial to our standards and reputation.

Miscellaneous

27. Casterbridge Tours is the trading name of Casterbridge Tours Ltd. registered in England No. 2613749, Registered address: Salcombe House, Long Street, Sherborne, Dorset, England DT9 3BU.

28. Any booking by whomsoever it is made is only accepted by Casterbridge Tours on the condition that it is subject to English Law and must be interpreted and enforced in an English Court of Law.
